The board of directors (the "Board") of Top Form International Limited (the "Company) is please to announce that Ms. Leung Churk Yin, Jeanny has been re-designated as an independent non-executive Director of the Company with effect from 19 September 2008. She has also been appointed as a member of the Compensation Committee of the Company with effect from 19 September 2008.

Ms. Leung, aged 43, had been appointed as an executive Director of the Company in February 1998 and then re-designated as a non-executive Director since April 2000 and is currently a member of the Audit Committee of the Company. Ms. Leung is the current executive director and chief executive officer of eSun Holdings Limited, an executive director of Lai Sun Garment (International) Limited, Lai Sun Development Company Limited and Lai Fung Holdings Limited, all of which are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). Ms. Leung has over 20 years of corporate finance experience in Hong Kong, the Mainland China and Taiwan.

Save as disclosed above, Ms. Leung had not held any directorship in public listed companies or other major appointment in the last three years.

Ms. Leung has not entered into a service contract with the Company and she has not been appointed for a specific term of service and is subject to retirement by rotation in accordance with the New Bye-laws of the Company. For the year ended 30 June 2008, the Director's fee received by Ms. Leung was HK\$200,000. The Board determined this fee on the prevailing market conditions and the time and effort Ms. Leung spent in the Group's affairs.
